Payment Policies:

- ⤴ **THERE WILL BE NO REFUNDS.**
- ⤴ **Tuition is due the first of each month. Tuition not received by the 20th of the month is subject to a \$15 late charge.** You will not receive an invoice by US mail, but you will receive an email reminder from our office the first week of each month.
- ⤴ **THERE WILL BE A \$25 CHARGE FOR ALL RETURNED CHECKS.**
- ⤴ **WITH THE EXCEPTION OF JULY AND AUGUST ONLY, THERE WILL BE NO ADJUSTMENT OF TUITION, NO EXCEPTIONS.**
- ⤴ If a student attends the first class of the month and the office is not notified of a change of schedule, the entire month of tuition will be due. **TUITION IS NOT BILLED BASED ON STUDENT ATTENDANCE, BUT BASED ON CLASS ENROLLMENT THROUGH OUR OFFICE.**
- ⤴ **Make-up lessons:** Every student has one month to make up a missed class. A student may not take a make-up lesson if his/her account has been adjusted for vacation or if he/she is no longer enrolled in any classes. A student may not take a make-up lesson in the class in which he/she is enrolled in lieu of payment.
- ⤴ Every student must notify their teacher of any class enrollment changes (add/drop), as well as come to the office to fill out an add/drop form.
